

AMENDMENT TO CONTRACT AGREEMENT

The amendment to the Contract Agreement herein stated shall neither incur additional cost to the Entity nor cause an extension to the delivery period.

Except as otherwise expressly stated herein, all of the terms and conditions set forth in the Contract Agreement remain unchanged and in full force and effect.




